Infection Control: Use of Transport	Staff Pupils Others	<ul style="list-style-type: none"> <li><b>From 27 January</b>, staff and pupils should follow <a href="https://www.gov.uk/government/publications/face-coverings-when-to-wear-one-and-how-to-make-your-own">https://www.gov.uk/government/publications/face-coverings-when-to-wear-one-and-how-to-make-your-own</a> outside of school, including on transport to and from school.</li> <li>It is important to ensure vehicles are well ventilated when occupied, by opening windows and ceiling vents. The need for increased ventilation while maintaining a comfortable temperature should be balanced.</li> <li>On dedicated transport:</li> <li>It is no longer recommended maximising distance and minimising mixing, but unnecessary risks such as overcrowding should be minimised.</li> <li>Children, young people and adults should follow United Kingdom Health Security Agency (UKHSA) advice on when to self-isolate and what to do.</li> <li>They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li> <li>If a child or young person develops COVID-19 symptoms, however mild, while at school, they will be sent home.</li> <li>They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li> </ul>	MED	20.01.2022

Infection Control: Cleaning of school	Staff Pupils Others	<ul style="list-style-type: none"> <li>All hard surfaces to be cleaned on a regular basis, this will include <ul style="list-style-type: none"> <li>All door handles</li> <li>All tables and chairs used by staff and pupils</li> <li>Toilet flushes and regular cleaning of toilets.</li> </ul> </li> <li>All classrooms to have spray disinfectant and where possible disposable cloths. If disposable cloths are not available use once and then put in wash.</li> <li>Regular cleaning of surfaces will reduce the risk of spreading the virus.</li> <li>All used cloths thrown away to be double bagged and then placed in a secure area i.e. lockable bin.</li> </ul>	MED	<p>Lunchtime cleaning required. <p>Ill Health: Poor hygiene practice</p>	<p>Staff Pupils Others</p>	<ul style="list-style-type: none"> <li>You should continue to ensure that children clean their hands regularly, this can be done with soap and water or hand sanitiser</li> <li>Staff and visitors are encouraged to wash their hands with soap or alcohol-based sanitiser (that contains no less than 60% alcohol) and follow infection control procedures in accordance with the DfE and PHE's guidance.</li> <li>Sufficient amounts of soap (or hand sanitiser where applicable), clean water and paper towels are supplied in all toilets and kitchen areas.</li> <li>Pupils are supervised by staff when washing their hands to ensure it is done correctly, where necessary.</li> <li>Pupils are discouraged from sharing cutlery, cups or food.</li> <li>All cutlery and cups are thoroughly cleaned before and after use.</li> <li>Cleaners to carry out daily, thorough cleaning that follows national guidance and is compliant with the COSHH Policy and the Health and Safety Policy.</li> <li>A senior member of staff arranges enhanced cleaning to be undertaken where required – advice about enhanced cleaning protocols is sought from the HPT/PHE</li> </ul>	<p>MED</p>	<p>Regular hand washing in all year groups and signage in school to encourage hand washing and good hygiene</p> <p><b>JD / Vice Principal / NS (Site Manager)</b></p> <p><b>All staff</b></p> <p><b>20.01.2022</b></p>
<p>Lack of infection control: Spread of infection</p>	<p>Staff Pupils Others</p>	<ul style="list-style-type: none"> <li>Spillages of bodily fluids, e.g. respiratory and nasal discharges, are cleaned up immediately in line with guidance, using PPE at all times.</li> <li>Parents are informed not to bring their children to school or on the school premises if they show signs of being unwell and believe they have been exposed to coronavirus.</li> <li>Staff and pupils do not return to school before the minimum recommended exclusion period (or the 'self-isolation' period) has passed, in line with national guidance.</li> <li>Pupils who are unwell are not taken on school trips or permitted to enter public areas used for teaching, e.g. swimming pools.</li> <li>Parents notify the school if their child has an impaired immune system or a medical condition that means they are vulnerable to infections.</li> <li>The school in liaison with individuals' medical professionals where necessary, reviews the needs of pupils who are vulnerable to infections.</li> <li>Any additional provisions for pupils who are vulnerable to infections are put in place by the Principal, in liaison with the pupil's parents where necessary.</li> </ul>	<p>MED</p>	<p>Ensure all stakeholders (Staff, parents and pupils) are fully informed of control measures, policies and safety procedures</p> <p><b>JD / Vice Principal / NS (Site Manager)</b></p> <p><b>All staff</b></p> <p><b>14.12.21</b></p>

Infection control: Personal Protective Equipment Face Coverings	Pupils Staff	<ul style="list-style-type: none"> <li><b>From 27 January 2022</b>, we no longer recommend that face coverings should be worn by any pupils, students, staff or adult visitors when moving around premises, such as in corridors and communal areas. Everyone should follow wider advice on face coverings outside of education settings, including on transport to and from education settings.</li> <li>Face coverings in communal areas may temporarily, and exceptionally, be advised by DsPH: for an individual setting, as part of their responsibilities in outbreak management for settings across areas where DfE and public health experts judge the measure to be proportionate, based on the evidence public health experts share with the DfE and specific local public health concerns.</li> <li>For example, where the area has been designated as an enhanced response area,</li> </ul>	MED	<p>Face coverings still advised for large communal events e.g. parents' evenings etc</p> <p><b>All staff</b></p> <p><b>20.01.2022</b></p>

<p>Coronavirus Symptoms: Ill Health</p>	<p>Staff Pupils Others</p>	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> <li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li> <li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li> <li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li> <li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li> <li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li> <li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill</li> </ul>	<p>MED</p>	<p>Clear communication on symptoms and expectations regarding illness and procedures if children are unwell</p> <p><b>All staff</b></p> <p><b>14.12.21</b></p>

<b>Infection control:</b> <b>Primary School Pupils</b> Autumn Term Asymptomatic testing	Pupils Staff	<ul style="list-style-type: none"> <li>From the 21<sup>st</sup> of February, staff and students in mainstream secondary schools will not be expected to continue to take part in regular asymptomatic testing and should follow testing advice for the general population.</li> <li>In the event of an outbreak, a school may be advised by their local health team or director of public health to undertake testing for staff and students of secondary age and above for a period of time.</li> <li>Staff and pupils in specialist SEND settings, Alternative Provision and SEND units in mainstream schools are advised to continue regular twice weekly testing.</li> </ul>	MED	Staff only to continue testing regime  <b>All staff</b> <b>14.12.21</b>
<b>Teaching Staff Absences</b> <b>Infection control</b>	Pupils Teaching Staff	<ul style="list-style-type: none"> <li>To help make sure students can continue to be in school with their friends and all the benefits that brings, settings could consider asking teachers to deliver lessons from home, which are then streamed to classrooms in schools and colleges.</li> <li>In these instances, classrooms should of course be supervised by another member of staff, which could include support staff like teaching assistants.</li> <li>As pupils do not need to be kept in consistent groups, schools and colleges may wish to consider combining classes.</li> </ul>	MED	
<b>Pupil Absences due to COVID</b> <b>Infection control</b>	Pupils	<ul style="list-style-type: none"> <li>If children or young people cannot attend school or college either because they have tested positive or have symptoms, but are well enough to continue studying, any remote education should mirror that received in the classroom as closely as possible. That should focus on live lessons - alongside time for students to complete tasks independently - for a minimum of five hours a day in secondary schools and slightly less in primaries</li> </ul>	MED	
<b>New Variant of Concern – Omicron</b>	Staff Pupils Others	<ul style="list-style-type: none"> <li>At present, the Omicron variant of COVID- 19 is the dominant strain. Following the latest public health advice, we know that Omicron presents low risk to most children, young people and fully vaccinated adults.</li> <li>Most people will only experience mild or asymptomatic illness which combined with vaccination allows education testing to be in line with the wider society and bring greater normality to the school day.</li> </ul>	MED	All staff <b>14.12.21</b>
<b>Visitors to schools</b>	Visitors Contractors	<ul style="list-style-type: none"> <li>Settings are strongly encouraged to ask parents, guardians and other visitors to take a lateral flow device (LFD) test before entering the setting.</li> </ul>	MED	JD/SLT <b>14.12.21</b>

<p>Self-isolation and managing positive cases</p> <p>Infection control</p>	<p>Pupils Staff</p>	<ul style="list-style-type: none"> <li>From the 24<sup>th</sup> of February, the Government will remove the legal requirement to self-isolate following a positive test. In addition, the Government will no longer ask fully vaccinated close contacts and those aged under 18 to test daily for 7 days and routine contact tracing will end.</li> <li>Adults and pupils who test positive will continue to be advised to stay at home and avoid contact with other people for at least 5 full days and then continue to follow guidance until they have received 2 negative test results on consecutive days.</li> <li>Staff, children and young people who are contacts should attend their education settings as usual. This includes staff who have been in close contact with their household, unless they are able to work from home.</li> <li>If anyone has any of the main symptoms or a positive test result, the public health advice remains unchanged and is to stay at home and avoid contact with other people.</li> <li>Anyone with any of the main COVID-19 symptoms should order a test and is advised to stay at home while waiting for the result. <ul style="list-style-type: none"> <li>If they test positive, they are advised to follow public health advice.</li> </ul> </li> </ul>	<p>MED</p>	<p>Staff and parents informed of routines and arrangements regarding contact tracing and isolation</p> <p><b>JD / AB (Vice Principal)</b></p> <p><b>All staff</b></p> <p><b>14.12.21</b></p>
<p>Living in same household with a pupil/sibling with a positive case</p> <p>Spread of infection</p>	<p>Siblings Pupils Others</p>	<p><b>From 16 August 2021</b>, you will not be required to self-isolate if you live in the same household as someone with COVID-19 and any of the following apply:</p> <ul style="list-style-type: none"> <li>You are fully vaccinated</li> <li><b>You are below the age of 18 years 6 months</b></li> <li>You have taken part in or are currently part of an approved covid-19 vaccine trial</li> <li>You are not able to get vaccinated for medical reasons</li> </ul> <p>As long as the pupil/sibling is not displaying any COVID-19 symptoms, then the above guidance applies.</p> <p>Pupils aged 5 years and over and live in the same household as someone with COVID-19, and are not legally required to self-isolate, are strongly advised to:</p> <ul style="list-style-type: none"> <li>Take an LFD test every day for 7 days, or until 10 days after the household member who has COVID-19 started their self-isolation period if this is earlier</li> <li>Take this daily LFD test before you leave your home for the first time that day</li> <li>If an LFD test is positive, you should immediately self-isolate to prevent you from passing the infection on to other people.</li> </ul>	<p>MED</p>	
<p>Returning to school after a positive LFT/PCR</p>	<p>Staff Pupils</p>	<ul style="list-style-type: none"> <li>Adults and pupils who test positive will continue to be advised to stay at home and avoid contact with other people for at least 5 full days and then continue to follow guidance until they have received 2 negative test results on consecutive days.</li> </ul>	<p>LOW</p>

Lack of infection control: Poor management of infectious diseases	Staff Pupils Others	<ul style="list-style-type: none"> <li>• Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus.</li> <li>• Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible.</li> <li>• The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus.</li> <li>• The school is informed by pupils' parents when pupils return to school after having coronavirus – the school informs the relevant staff.</li> <li>• Staff inform the Headteacher when they plan to return to work after having coronavirus.</li> <li>• A nominated person monitors the cleaning standards of school cleaning contractors and discusses any additional measures required with regards to managing the spread of coronavirus.</li> </ul> <p><a href="https://publishing.service.gov.uk">Contingency framework: education and childcare settings (publishing.service.gov.uk)</a></p> <p><b>The thresholds, detailed below, can be used by settings as an indication for when to seek United Kingdom Health Security Agency (UKHSA) or Local Public Health advice if they are concerned.</b></p> <p>For most education and childcare settings, whichever of these thresholds is reached first:</p> <ul style="list-style-type: none"> <li>➤ 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or</li> <li>➤ 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period</li> </ul> <ul style="list-style-type: none"> <li>• For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time:</li> <li>• All settings should seek United Kingdom Health Security Agency (UKHSA) or Local Public Health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern. Local Public Health support in managing risk assessments and communicating with staff and parents.</li> <li>• Settings may wish to seek additional United Kingdom Health Security Agency (UKHSA) or Local Public Health advice if they are concerned about transmission in the setting.</li> </ul>	MED	<p>Clear communication on symptoms and expectations regarding illness and procedures if children are unwell</p> <p><b>All staff</b></p> <p><b>14.12.21</b></p>

<p>Unsafe Practices: Lack of communication</p>	<p>Staff Pupils Others</p>	<ul style="list-style-type: none"> <li>• The school staff reports immediately to the headteacher about any cases of suspected coronavirus, even if they are unsure.</li> <li>• The headteacher contacts the local HPT or follows the advice given from and discusses if any further action needs to be taken.</li> <li>• Schools put into place any actions or precautions advised by their local HPT.</li> <li>• Schools keep staff and parents adequately updated about any changes to infection control procedures as necessary.</li> </ul>	<p>MED</p>	<p>Clear communication on symptoms and expectations regarding illness and procedures if children are unwell</p> <p><b>All staff</b></p> <p><b>14.12.21</b></p>
<p>Travel and quarantine</p>	<p>Staff Pupils Others</p>	<ul style="list-style-type: none"> <li>• All travellers arriving into the UK will need to isolate and get a PCR test by 'day two' after arrival. They may end their isolation once they receive a negative result. If the result is positive, they should continue to isolate and follow rules on isolation following a positive test.
